FLAMBOYANT (FR) saved ground chasing the pace, moved up inside then came out in midstretch and rallied under left handed urging to get up in the final stride. OBVIOUSLY (IRE) had speed outside foes then angled in, set the pace on a clear lead along the inside and held on well but was edged on the wire. BAL A BALI (BRZ) between horses early, angled in and stalked inside, came out into the stretch and bested the rest. POSHISKY chased a bit off the rail then outside a rival, came out into the stretch and lacked the needed late kick. POWER PED angled in and saved ground chasing the pace, came out a bit in the stretch and lacked the needed rally.sett. TEXAS RYANO settled outside a rival then a bit off the rail, continued inside on the second turn, came out into the stretch and could not offer the necessary response. CHIROPRACTOR three deep early, chased outside a rival then inside into and on the second turn and did not rally. BIG JOHN B unhurried inside then outside a rival on the backstretch, came out into the stretch and lacked the necessary response. KENJISSTORM stalked three deep then outside a rival, came three wide into the stretch and weakened. WANSTEAD GARDENS unhurried and angled in outside a rival early, chased off the rail, came out into the stretch and gave way. MACRO ACCESS (ARG) had speed between horses then stalked outside a rival, dropped back between foes on the second turn, was pulled up in the stretch and vanned off.
